Response: FACTUAL REVIEW REQUEST

Basis for Review: CA dates are not per the guidelines

Operator Comment: The Corrective Action date is not immediate or 30 days as prescribed by the Corrective Action Matrix. It is dated before the FIR submitted date on the inspection, and is even dated before the date of discovery by the inspector. Per COGCC Guidance: "It is important to note that corrective action dates must be based off of the date the FIR was submitted to the operator and not the date of inspection."

COGCC Decision: **Not Approved**

COGCC Representative: The inspection was entered for notification and documentation only and was not intended to provide the Operator the opportunity to resolve the alleged violations without the imposition of a penalty, pursuant to Rule 522.c.(1). Strict compliance with the Corrective Action Matrix Guidance would have frustrated that intent and, therefore, Staff exercised its discretion to select a more appropriate corrective action date.

Operator shall install stormwater and erosion control BMPs in accordance with good engineering practices per Rule 1002.f.(2), and BMPs shall be installed prior to, or at, the start of construction. Operator failed to install the silt fence BMP in accordance with good engineering practices during construction activities; therefore, the corrective action remains open until resolved.

It should be noted that Staff contacted and communicated to the Operator on February 7, 2018 that the silt fence BMP was not properly installed. Operator communicated to Staff on February 8, 2018 that BMP repairs were underway. However, observations on February 9, 2018 indicated that no BMP repairs had been performed.

COGCC Supervisor: The inspection was entered for notification and documentation only and was not intended to provide the Operator the opportunity to resolve the alleged violations without the imposition of a penalty, pursuant to Rule 522.c.(1). Strict compliance with the Corrective Action Matrix Guidance would have frustrated that intent and, therefore, Staff exercised its discretion to select a more appropriate corrective action date.

Operator shall install stormwater and erosion control BMPs in accordance with good engineering practices per Rule 1002.f.(2), and BMPs shall be installed prior to, or at, the start of construction. Operator failed to install the silt fence BMP in accordance with good engineering practices during construction activities; therefore, the corrective action remains open until resolved.
