This is a short corrective action date since weed debris has accumulated in the perimeter fences. Comment

This location is not in compliance with Rule 1003 standards. The southern interim area fails due to the high abundance of weedy, annual vegetation (Russian thistle). Unmanaged weed debris was observed in the perimeter fences. Operator has failed to manage, control, and remove weeds (Russian thistle) to prevent weed debris and to prevent dispersing seeds onto adjacent lands.

Corrective Action

Perform reclamation activities in accordance to COGCC 1003 reclamation rules and requirements to bring this location into compliance. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Interim reclamation activities shall be complete no later than May 14, 2018.
