Comment: **This location does not meet reclamation regulations; insufficient vegetative cover. Access road does not appear to have been reclaimed; road remains graveled and has not achieved uniform desirable vegetative cover. Straw wattle stormwater BMPs have not been maintained, are in disrepair and is considered debris. Vegetation on location does not appear to have achieved a uniform desirable vegetative cover on the northern/western areas when compared to the reference area. See attached photo document**

Corrective Action:	Maintain stormwater and sediment control BMPS or remove debris. Perform reclamation in accordance to COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To take advantage of the 2018 spring growing season, revegetation activities shall be complete no later than 4/30/2018	Date	04/30/2018
