COMMENTS:

Noble plans to remove production equipment from 1,297 production or well locations (see attached facility list - Correspondence) as a result of its Consent Decree compliance plan. Noble plans to plug and abandon all vertical wells associated with each of the 1,297 surface facilities they are decommissioning. Once Noble decommissions a production facility the associated wells will be temporarily abandoned ("TA") per Rule 326.c, which would trigger obligations under Rules 319.b and 326.c., including the requirement to perform a mechanical integrity test (MIT) on each TA'd well. Noble hereby requests a Rule 502.b. variance from the MIT requirement of 326.c and the annual Form 4, Sundry Notice reporting obligation of Rule 319 .b. With this variance request, Noble seeks to satisfy the prior approval requirement of Rule 319.b as to all 993 wells where Noble proposes to remove surface equipment.
