**General Comment:**

Environmental inspection conducted in response to spill report doc #401547592. Sunny day. Temp around 40 oF. Snow in the ground. On Site with Dwayne Knudson from URSA. A tank leaked due to a hole at the bottom of the tank. Approx. 110 bbls of fluids leaked and contained in the lined secondary containment. Fluid had been removed. Tank will be decommissioned. No sign of hydrocarbon was observed outside of the secondary containment. URSA inspected the liner and found no evidence of hole or any sign that could indicate a compromised liner.

No junk or trash was observed on site. Wellheads and tanks have labels. Tanks have steel lined secondary containment and the pad has a berm on the perimeter.
