Corrective Action: Perform reclamation; remove pipe and various debris remaining at well and battery location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 3/31/2018.

Operator Comment: Chevron is working to move this case to an active operator number through a form 10 so that a form 4 can be submitted to extend the deadline outside of the winter months so that revegetation activities will have a much higher probability of success.

COGCC Decision: **Not Approved**

COGCC Representative: COGCC decision "Not Approved": Operator resolution response of "Corrective action complete" notifies the state that the corrective action has been addressed in its entirety.

Comments provided by operator indicate that the corrective action has neither been addressed or completed.

OPERATOR COMMENT AND SUBMITTAL

Comment: It has taken some time for Chevron to determine if it is our legal responsibility to conduct the final reclamation on this well, as British American Oil Production Company is not a name that we conduct business under. Additionally, Chevron believes that achieving 80% natural ground cover by March 31st, 2018 is an unattainable request. Consequently, Chevron has now determined that it is probable that the reclamation is our responsibility and as such will agree to remediate the location, but due to the short timeframe are requesting an extension. This is being conducted in an FIR as operator number 10558 is not a number that we operate under. A form 10 will be submitted to request transfer of the well to an operating company that Chevron operates under in Colorado when the permitting specialist returns from vacation on Monday. After the form 10 is submitted, I will follow up with an official form 4 request for extension.
