COMMENTS:

Pioneer is requesting continued temporarily abandon status on the General Vera 11-28 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for continued temporarily abandon status was submitted to the COGCC on 9/6/2016. A Mechanical Integrity Test dated 3/27/2013 has also been previously submitted. The General Vera well is closed to the atmosphere via a wellhead secured and shut-in by a valve as well as a bridge plug set at 820'. This well is being planned for plugging and abandonment.
