On 2-22-2018 at approx 0700 hrs I attempted to contact the complainant. I performed an inspection of the area around the complaints home and did not detected any odors coming off any of the oil and gas operations in the area. I performed an inspection of the oil and gas operations in the area and did not find any abnormal operations which could be causing the odors. I observed smoke coming from a smoldering pile in a field to the south of the complaints home.
