Comments:

Chevron is requesting that a timeline extension be granted until June 30, 2018, so that we can appropriately assess and adequately remediate this location with as little disturbance to the environment as possible. The Chevron remediation group did not receive permission from Chevron legal to begin executing the final remediation at this location until the end of February, as the well was never directly transferred to either Chevron nor a company that Chevron ever merged with. Furthermore, Chevron cannot find records of ever conducted business in Colorado under the name British-American Oil Production Company. Consequently, before proceeding on the remediation Chevron was required to conduct a legal review to determine if the remediation of the well in question was indeed Chevron's responsibility. Having received permission from legal to conduct the remediation for this particular well at the end of February, Chevron is requesting an extension of three months to the initial proposed date to complete the remediation which had been set at March 31, 2018. We are requesting that a timeline extension be granted until June 30, 2018, so that we can appropriately assess and adequately remediate this location with as little disturbance to the environment as possible.
