## COMMENTS:

Vanguard Operating respectfully requests to add equipment at this location. A natural gas fired compressor and associated infrastructure will be installed to gas lift all existing wells on the location. There are no building units within 1000' and changes will not add additional disturbance beyond what was originally permitted.

The compressor has been tested with a sound level meter and the readings comply with COGCC Rule 802.b. Vanguard will be adding additional sound mitigation which consists of a four sided, metal enclosure with a roof. This enclosure will assist with operations during winter weather conditions and ensure noise levels are below the permissible noise levels associated with zoning for Residential/Agricultural/Rural areas (7am- 7pm, 55 db(A) and 7pm-7am, 50 db(A)) in COGCC Rule 802.b.

Vanguard is currently scheduled to initiate installation activities at this location March 26, 2018 and would greatly appreciate an expedited approval of this request.  
Adding: 1 Gas Compressor and initiating gas lift on all fourteen existing wells on the location
