ALLEGED VIOLATION – Operator was granted a one-time only, extension of the use of the Magellan Drilling Pit. The Drilling Pit is to be closed no later than November 15, 2017. Pit remains open as of inspection on 2/28/2018. COGCC Remediation #10865 was approved for pit closure on 1/10/2018. The COGCC has not received any further documentation of pit closure and the pit remains open 105 days past the closure date (see attached photos).
