On 3-5-2018, I was contacted by complaint specialist Megan Adamczyk in reference to an odor complaint received for 3-5-2018 by the COGCC about possible oil and gas odors occurring in the Windsor area east of the complaints residence.

On 3-5-2018 at approx 1400 hrs I performed inspections of the oil and gas operations east of the complainant's residence. I observed no activity at the Milkshake location as it was being prepped for fracking operations. At the Raindance location I observed regular production activity at location. At no time did I observe any activity which could be causing the complaints odors on or off location. I also went to the complaints residence and checked for odors at no time during my investigation did I detect any odors on or off locations in the area.

All information reviewed and site inspection information were submitted to the COGCC for further review.
