CIBP topped with 2 sxs cement was set down hole at 6492' for the purposes of WBI mitigation for an offset frac. Tubing was pulled, plug and casing were pressure tested up to 2500 psi for 15 mins and a 5K wellhead was installed. At this time, PDC intends to RTP this well upon the conclusion of the frac.
