**WAIVER AND CONSENT PURSUANT TO RULE 316**

WHEREAS, Stuarco Oil Company, Inc. is a lessee and operator of all the oil and gas leasehold rights located in Larimer County, Colorado described as follows:

Township 9 North, Range 68 West, 6th P.M.

Lessor's Reservoir No. 3 located in parts of SW $\frac{1}{4}$  SE $\frac{1}{4}$  and SE $\frac{1}{4}$  SW $\frac{1}{4}$  Section 18, and that part of the NW $\frac{1}{4}$  lying North and East of the inlet canal to the Lessor's Reservoir No. 3, NE $\frac{1}{4}$ , NW $\frac{1}{4}$  SE $\frac{1}{4}$ , and that part of the E $\frac{1}{4}$  SE $\frac{1}{4}$  lying inside of and below a line drawn 100 feet above and parallel to the high water contour line of Reservoir No. 3 of The North Poudre Irrigation Company in Section 19. Lessor intends to lease all lands owned in Section 19; and

WHEREAS, the undersigned are the owners of the oil and gas leasehold rights in the S/2 SE $\frac{1}{4}$  of Section 18 and desire to waive any objection and to consent to the drilling of an oil or gas well located 220 feet from the North line and 2,580 feet from the East line of Section 19, Township 9 North, Range 68 West, even though the said location does not conform to the provisions of Rule 316 of the Oil and Gas Conservation of the State of Colorado.

NOW, THEREFORE, the undersigned hereby waives any and all objections to said location and advises the Commission of its consent thereto.
