Per conversation between Steve Wolf and Hunter Dunham on 3/28/18, Noble will elect to perform Option 4 as an offset to Verdad's Jackson pad in sec 28/33 2N-64W. As part of the Option 4, Noble will monitor casing and surface casing pressures during the stimulation job for any pressure on the surface casing gauge during frac and communicate any variances to the baseline pressure to Verdad.
