Comment: Follow up to site inspection of 12/18/17. TPH-contaminated pit spoils are being landfarmed under approved REM 10464. Landfarm is 100% bermed with soil lift ~18 inches. Trachhoe on site and material and been amended w manure and re-tilled. Small stockpile (<75cy) has also been mixed w manure. Pit remains open. Staining and odor is minimal vs 12/18 when soils were heavily stained w strong petroleum odor.

Corrective Action: Continue O&M of landfarm and pit cleanup operations including scheduled tillage until confirmation soils samples from landfarm, pit, and other soils are Table 910-1 compliant. Recycle treated soils for beneficial re-use as backfill or other approved placement.
