Comment Revegetation has failed in the western and southwestern project area. Additionally 100 musk thistles were observed in the project area.

Corrective Action Revegetation needs to be conducted in portions of the project area with little vegetation (largely in the western and southwestern project area) no later than May 1, 2018. Mulching will likely be needed for vegetation establishment. Weeds need to be controlled at the appropriate time but no later than June 15, 2018.
