CAUSE INFORMATION: A pipeline that was buried 5 ft underground on the caller's property broke, releasing a pond about 30 ft square on land. The caller contacted Great Western Oil, who he believes to be the owner of the pipeline. They sent out Mike Hettinger, a construction supervisor, who had the release shut off by 2 pm. Caller had the number listed above for Great Western Oil. They are not giving him any information and he is concerned about possible risks to his family from this release. He would appreciate a call from someone who can advise him regarding this issue. He does not know what type of oil is carried in this pipeline. He noted that the release was very hot and that there was a lot of steam released. There was no waterway nearby.
