Attention Stan Spencer: Utah Gas Corp requests the closure of Pit #117045 located at facility # 31433 (Dragon Trail 5002). This is a location where no remediation number was issued by the COGCC, but removal and remediation of the pit occurred. A sundry was submitted in 2013 but no record of approval was received from the COGCC at the time. The COGCC database has a copy on file for the location. (Doc#400499815) A copy of the remedial report is attached to this submittal. Also, a satisfactory COGCC inspection occurred on 6/23/15 (Doc #675101541) - no issues, no indication of a surface pit.
