Comment: Appears the pit has been backfilled but vegetation is not reflective of reference area vegetative levels. The vegetative growth within portions of the pit consists mainly of Cheatgrass (Bromus tectorum).

The well location appears to meet Rule 1004 standards.

Corrective Action:	Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than May 15, 2018 or sooner depending on favorable environmental conditions.	Date	05/15/2018
