Basis for Review: Action requested was already completed prior to the inspection

Operator Comment: The F25 496 was interim reclaimed in November/December 2012. The location was initially seeded 12/5/2012 and then touch up seeding was applied 07/18/2013. The location was reduced from its original footprint of 7.62 Acres to 3.1 acres. The total area interim reclaimed was 4.52 acres. The associated google imagery (attached) shows the 2011 footprint (orange) and the 2015 footprint (green). The current operational footprint will be used for safe and adequate traffic flow, work over operations, and snow removal and storage. We believe that Caerus has met the intent of the regulation and believe that the F25 496 is in compliance with COGCC Rule 1003.b., "All disturbed areas affected by drilling or subsequent operations, except areas reasonably needed for production operations... shall be reclaimed as early and as nearly as practicable to their original condition or their final land use as designated by the surface owner and shall be maintained to control dust and minimize erosion to the extent practicable."
