Field Inspector Actions:
On 4-12-2018, I was contacted by Jason Gomez of COGCC in reference to a sound complaint. The complainant stated the issues were coming from the Hergert 35-L Pad currently in the drilling process. (location ID 453075).

On 4-10-2018, I made contact with the drilling rig supervision and informed them of the nature of the complaint. They were aware of the noise issue as they were in process of tripping out of hole the evening prior, and experiencing mechanical issues while doing so. Per Extraction rig supervisors, they have corrected the issues.

I did not perform a sound study at time of inspection as there was a steady N/NE wind at 11mph.

On 4-13-2018, I made contact with the complainant, at approximately 9:29am. I informed him of the upset condition causing the above average noises. He understood and informed me that the noise seemed to subside, however it cannot be confirmed due to extremely high winds over the night and throughout the day.

No violation of COGCC rules were observed at the time of the inspection.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
