2. RU wireline company.
3. TIH with CIBP. Set BP at 7064'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6797'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 1900'. Pull cut casing.
6. TIH with tubing to 2025'. RU cementing company. Mix and pump 255 sxs 15.8#/gal CI G cement w/ 2% CaCl down tubing (cement coverage from 2025'-1600'). TOOH with tubing.
7. Pick up tubing to 800'. Mix and pump 375 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.
8. Cut surface casing 6' below ground level and weld on cap.
