## COMMENTS:

As per discussion and input from COGCC, Laramie is providing additional information related to Drill Cuttings Management. This material is intended to augment the details typically provided as part of our Form 2A submittal.

This material is intended to provide:

- A description of the cuttings management process.
  - Laramie's process for assessing cuttings constituents against Table 910-1.
  - Laramie's process for managing cuttings which exceed Table 910-1 criteria thresholds.
  - Typical volume of cuttings.
  - Laramie's process for incorporating cuttings into the Interim Reclamation process.
  - Analytical data gathered to assess cuttings constituent levels.
  - A general description of where cuttings will be incorporated (back) into the location after Table 910-1 criteria levels are met.
- To these ends, Laramie has attached a copy of our 2018 Cuttings Management Plan and the analytical data for cuttings generated at this location.
- Typically, Laramie generates 142 cu/yds of cuttings material per 8000 foot well. Depending on the number of wells drilled the total cuttings volume will range from 1500 cu/yds to 3000 cu/yds.
- Cuttings sampling is conducted via the collection of 5 samples (from the cuttings stockpile) at depths ranging from 6 to 12 inches. The 5 samples are combined into a composite sample and sent to the lab for analysis.
