A 7 bbl (300 gallon) cement water vault will be utilized to collect excess produced water from vapor recovery tower(s) processes. Produced water in the vault will be removed as needed and disposed of in an approved UIC disposal well. The cement water vault is one piece with no seams designed to minimize potential for leaks. 3. The partially buried cement water vault will be installed above the spray in liner.
