Dear Mr. Pierzchala,

This letter provides the Colorado Oil and Gas Conservation Commission (COGCC) findings and conclusion of Whiting Oil and Gas Corporation (Whiting) and Foundation Energy Management, LLC (Foundation) Form 10, Change of Operator and Pit Closure review. The COGCC conducted an exhausted review of files and the COGCC data base of the locations, wells, and pit facilities listed on Attachment A. The COGCC also engaged the Bureau of Land Management (BLM), who is the surface owner, to review their files and data base of the locations, wells and pit facilities listed on Attachment A.

In conducting the review and discussions the BLM on March 28, 2018 the following were determined:

- Based on inspections by the BLM, the pits where closed in accordance to the BLMs standards at that time and will pits will be administratively closed by the COGCC and the Form 10 will be processed from Whitening to Foundation.

However, there are two exceptions:

- In conducting the review inaccurate latitudes and longitudes (lat/long) were noted for APIs 05-081-07266 and 05-081-07210 on Location 311773. These wells have the same lat/long. Within 10-days of processing the Form 10 for this location and these wells, Foundation shall submit a Sundry Form 4 for each well providing the correct lat/long.
- Pit Facility ID: 268590, API 05-081-07133 has specific conditions of approval (COAs) when the pit was permitted. Either Whiting or Foundation shall provide
