The current operational footprint will be used for safe and adequate traffic flow, work over operations, and snow removal and storage. We believe that Caerus has met the intent of the regulation and believe that the M23 496 is in compliance with COGCC Rule 1003.b., "All disturbed areas affected by drilling or subsequent operations, except areas reasonably needed for production operations... shall be reclaimed as early and as nearly as practicable to their original condition or their final land use as designated by the surface owner and shall be maintained to control dust and minimize erosion to the extent practicable."
