Perform reclamation in accordance to COGCC 1000 series rules on the locatoin and access road, including by not limited to, removing gravel, compaction alleviation, regrading/recontouring and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 3/31/2018.

Date of Completion: 03/29/2018

Operator Comment: The operator worked on the site from 3/26/2018 to 3/29/2018. Prior to the drilling of the well, a road existed which ran from east to west and then approximately 1/4 mile to the southwest to a site owned by Sohio. The pre-existence of the road has been verified using the 2011 aerial photographs on the COGCC site. Wiepking-Fullerton Energy has conducted road reclamation work starting at the Sohio site and continuing to the Craig well site. The operator removed gravel, ripped the road tracks, hauled in top soil and drill seeded. The operator crimped in straw over the road site. The operator will monitor the road and drillsite.

COGCC Decision: **Not Approved**

COGCC Representative: After additional review, the east to west road existed prior to oil and gas activities. However, the remaining northern/southern traveling road was developed and utilized for oil and gas access.  
  
Wiepking-Fullerton was the last operator conducting activities and utilized the north/south portion of the road for oil and gas after the (Sohio) well was plugged and passed. Wiepking remains responsible for the reclamation of the remaining access road.
