Comment: **Operator has failed to remove equipment within three months of the plugging date (8/25/2017; Form 6 Doc.# 401406295). Meter house and a riser were observed at the battery location. Well location is not reflective of reference crop areas and subsidence is evident. A portion of the well location access road has no growth at all. Corrective action date is being back-dated to when final reclamation activities should have been completed. Refer to the attached inspection photos for more detail.**

Corrective Action:	(1) Remove remaining equipment from the battery location. (2) Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Comply with Rule 1004 to establish vegetation with, non-invasive, uniform plant cover of at least eighty (80) percent of reference area levels.	Date	11/25/2017
