Operator has failed to perform all final reclamation activities within three months of the plugging date (10/4/2017; Form 6 Doc.# 401439916). Well location is not reflective of reference crop areas. The well location and surrounding areas have no growth at all. Also, there appears to be other disturbances that might be associated with potential flowline abandonment. If that is the case, then the Operator shall comply with Rule 1004 throughout all disturbance areas of the flowline abandonment. Corrective action date is being back-dated to when final reclamation activities should have been completed. Refer to the attached inspection photos for more detail.		
Corrective Action:	Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
