10- 1-75	0 hours	Moved unit to location. Moved in and rigged up.
10- 2-75	0 hours	Dug two deadmen. Raised poles. Unseated pump. Started pulling rods.
10- 3-75	0 hours	Pulled 7/8" and 3/4" rods. (Hard breaking). Rigged up on tubing. Unseated anchor.
10- 6-75	0 hours	Pulled 2 7/8" tubing.
10- 7-75	10 hours	Dug cellar. Ran 130 gallons sand to 7560'. Dumped 5 sacks cement to 7518'. Set in jacks and equipment. Worked pipe to 22" tension. Gar-B loaded hole.
10- 8-75	12 hours	Ran shot to 6500'. Pumped 80 barrels oil and 165 barrels water. Pump. Gar-B water truck.
10- 9-75	8 hours	Worked pipe to 24" tension.
10-13-75	8 hours	Worked pipe to 24" tension. Broke out plug ret. Checked in to 6400'. Dumped 20 gallons sand on plug.
10-14-75	8 hours	Perf. holes at 2107' and 1820'. Pumped 45 barrels oil and 50 barrels water. Worked pipe to 27". Shut off top hole and circulated from bottom. Pump. Water truck, 8 hours.
10-15-75	8 hours	Worked pipe to 29" tension.
10-16-75	8 hours	Worked pipe to 31" tension.
