Corrective Action:	Operator has failed to perform final reclamation activities per the previous corrective action FIR. The well and battery location do not meet reclamation requirements. (1) The well location has not been contoured to match the surrounding landscape; rill erosion evident along the eastern cut slope. At a minimum, the Operator shall reduce the cut and fill slopes to prevent further erosion. The cut slope does not have any vegetation establishment. (2) The battery location is not reflective of reference area vegetative conditions and there is gully erosion which continues west, off location. Refer to the attached inspection photos for more detail.	Date 03/15/2018
	Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Final reclamation activities shall be complete no later than March 15, 2018.
