#### COMMENTS:

The Rogue 10-25 is approximately 5.36 miles from the nearest gas plant (Wiepking-Fullerton's Great Plains Field Gas Plant). Satellite photo is attached.  
The expected pipeline cost is estimated at \$240,000.  
Production test indicates the wells gas IP is 40 MCFD. Lease gas usage will be 15 MCFD.  
Using a \$240,000 in capital cost, 25 MCFD @ \$2.75/MCF in revenue and a 10% annual decline rate in gas production results in a never payout situation.  
Therefore, flaring of gas is requested. The initial flared daily volume will be 25 MCFD. Lease usage of gas will be 15 MCFD.  
Hydrogen Sulfide content of the gas is 0.5 ppm. The gas analysis report is attached.
