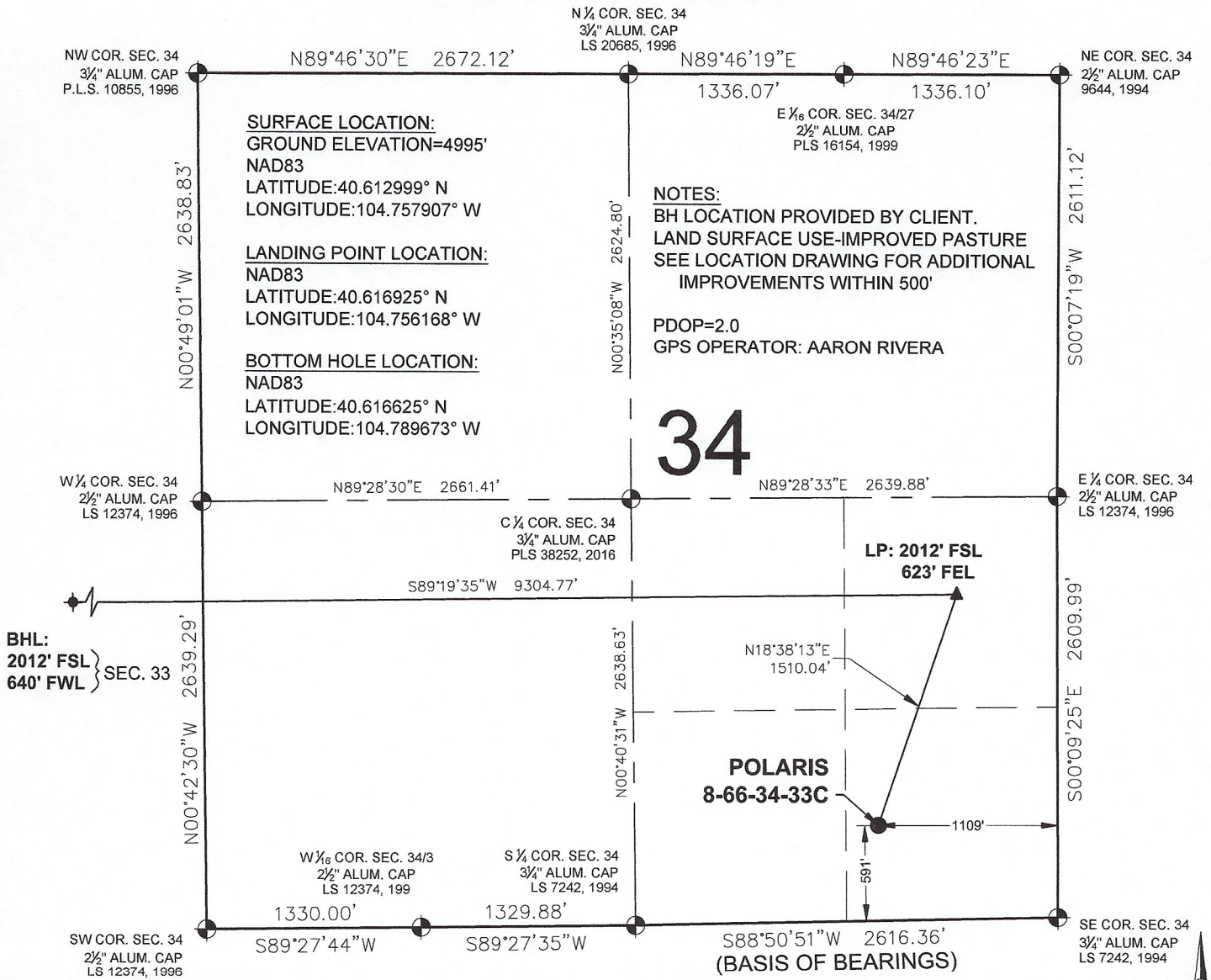


POLARIS 8-66-34-33C WELL LOCATION CERTIFICATE

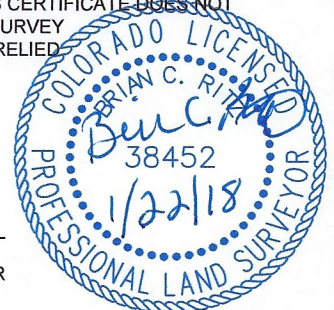

THIS LOW DISTORTION PROJECTION (LDP) IS BASED ON THE NORTH AMERICAN DATUM OF 1983, U.S. SURVEY FOOT WITH A LATITUDE ORIGIN OF 40.654718°N, A CENTRAL MERIDIAN LONGITUDE OF 104.772763°W, AND A SCALE FACTOR ON THE CENTRAL MERIDIAN OF 1.000241 (EXACT). 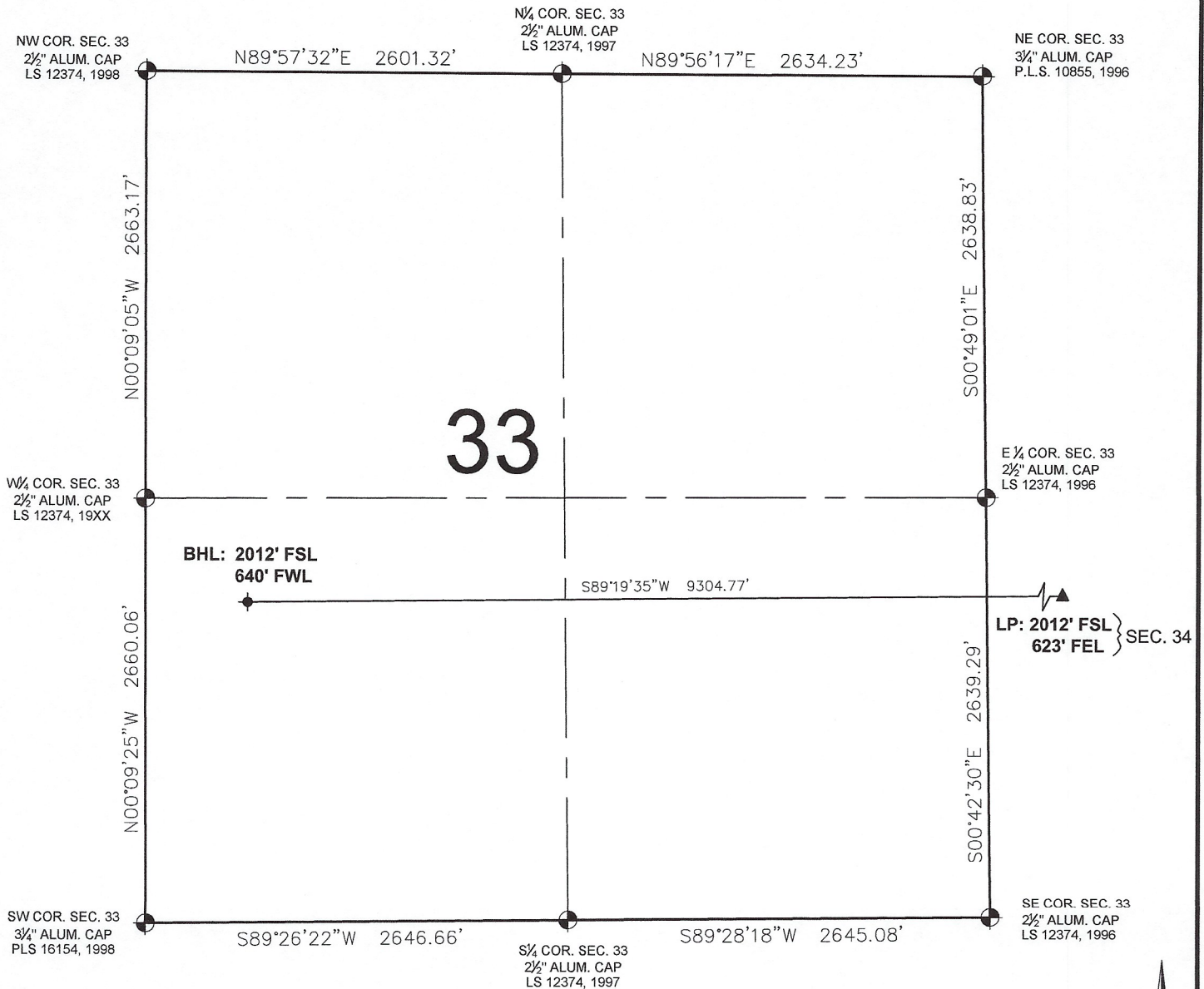
