Operator Comment: Two separate culverts along access road discussed in inspection report were cleaned out 11/15/2017. In addition, in November and December 2017, SG addressed several stormwater concerns, as well as the cut-slope erosion concerns identified on the 680602118, 689400633, and 680602285 inspection forms. Another inspection from 4/4/2018 (688800037) identified that the "cut slope did not appear to be stabilized as required by inspection document 680602118." On 11/16/2017, Denise Arthur granted SG an extension of the original CA date due to "many CA's SG was committed to conduct per the inspections" that occurred in the fall of 2017. This extension came with a required COA to install short-term BMPs by 11/30/2017 (same date as the original CA due date), in addition, SG must install long-term erosion controls no later than 5/30/2018. See attached email chain of approved extension, as well as the additional requirements of the original CA. SG was able to complete installation of a diversion ditch above the cut-slope to address the short term requirement by 12/15/2017 and installed Jute matting by 5/2/2018 to address the long term COA requirement. SG submitted a FIRR (401597789) on 4/5/2018 with photos of the diversion ditch installed then completed in December 2017. SG is now submitting this FIRR (401627747) to address the long term CA due by 5/30/2018. Attached are photos of the jute matting installed by 5/2/2018.
