Environmental**Spill/Remediation:**

Comment: COGCC followup inspection to #679700835 and spill ID#454672. Excavation remains open and evidence of petroleum impacted soil remains in sidewalls and base of excavation. Oily stockpile had been removed and pipeline has been repaired. It does not appear the excavation is materially larger than was observed on the 3/30/2018 site visit. During site visit, Operator stating that one additional soil sample collected from 11 feet below ground from a pothole in the base of the excavation contained a TPH concentration of approximately 1200 mg/kg. Operator stated their plan to advance soil borings to define the extent of impacts prior to additional excavation.

Corrective Action: Submit a Form 27 by May 4, 2018. The Form 27 shall include: a detailed plan for proposed additional site investigations, a description of remediation plans, all soil analytical data with site diagram showing sample locations for soil samples collected to date. Form 27 shall also include proposed dates to complete further investigation, excavation or remediation, and commencement of surface reclamation. Provide 48 hours notice of all future fieldwork to COGCC and to Surface Owner.
