Comment:

This site was first reclaimed in the fall of 2015, and reestablishment of desirable plant species is in progress. The presence of annual, non-noxious weeds in the early stages of reclamation is not unusual. Our experience is that desirable species require multiple growing seasons to reestablish, and more time is simply needed for this freshly reclaimed site.

In addition, a bareground weed treatment was conducted at this location on 4/3/17 and was effective in eliminating vegetation in the immediately vicinity of the equipment as shown in the photos. In addition, a noxious

weed treatment for Chicory occurred on 7/6/17. Active weed control will continue at this location in 2018, and throughout the interim reclamation time period.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approval/passing of the form 4 acknowledges that the Oil and Gas Conservation Commission has received the Notice. A field inspection will be conducted to evaluate compliance.

OPERATOR COMMENT AND SUBMITTAL

Comment: Bareground treatments in 2017 have been successful in the areas treated immediately around production equipment. Noxious weed treatments for Chicory were also conducted in 2017 were successful. This location was reclaimed in the fall of 2015 and simply needs additional time to allow for the permanent reestablishment of desirable plant species. This location will remain in TEPs inventory of sites that will receive active bareground and noxious weed treatments as necessary.
