Operator Comment: Topsoil at the location was salvaged and has been stockpiled. Topsoil in areas where the former Stelling facility was did not exist and all fill material was removed or recontoured during the initial construction operations.

Topsoil along flowline areas had been salvaged utilizing a double ditching method, and segregated during excavation, then backfilled immediately. Vegetation was grubbed along the flowline corridor as appropriate.
