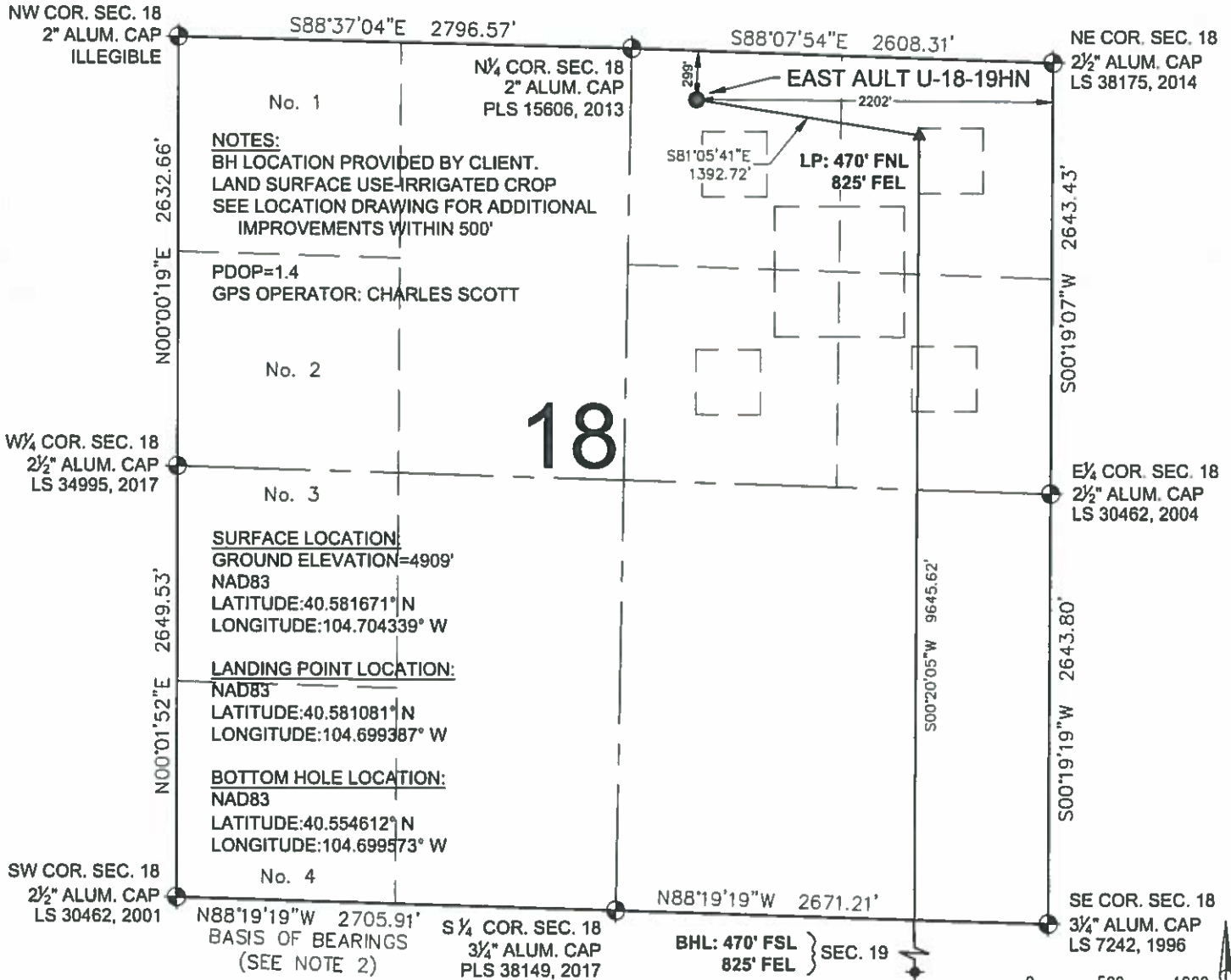


EAST AULT U-18-19HN WELL LOCATION CERTIFICATE

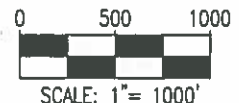

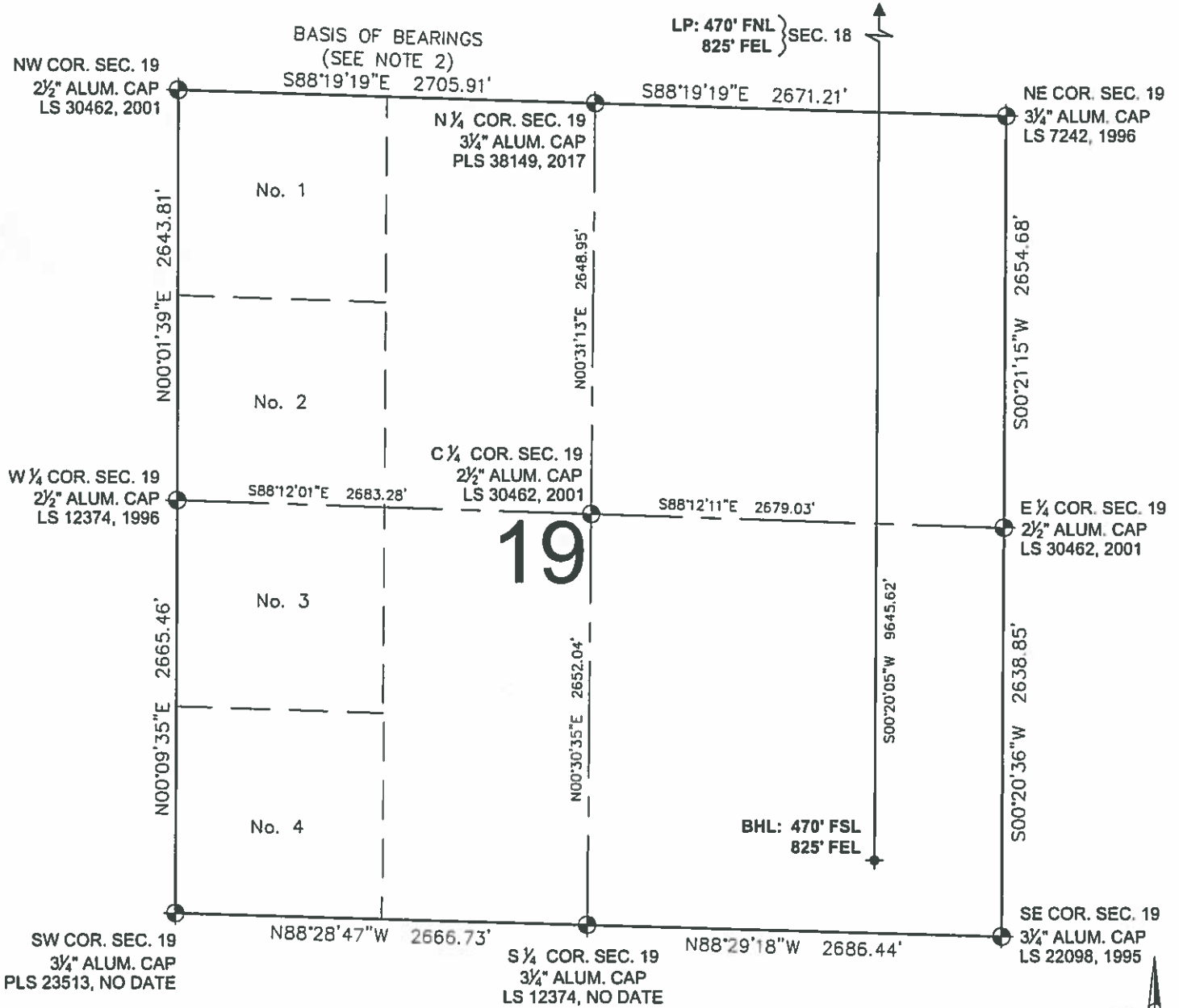
