The State of Colorado 39-36 was spudded on August 18, 2000, was determined to be dry, abandoned and plugged on August 29, 2000. As of March 1, 2018, the site is and has been native grass pasture used for grazing livestock. With the exception of the fence that was installed to keep livestock out of the reclaimed area the site has been reclaimed (which will be removed within the next two weeks), the site has been reclaimed. The State Land Board has recently inspected and approved the site. Please see the pictures.
