Comments:

The well is co-located on the same pad as the SRC TK 11-36D, 12-36D, 22-36D, and 36AD wells. Interim Reclamation was performed by the previous operator prior to the acquisition of the location by Bayswater. Due to the lack of records from the previous operator, the reclamation start date is estimated to be approximately 3 months after the spud date. Bayswater is in the process of maintaining the location to meet Rule 1003.e. requirements. Once vegetative cover and weed control requirements are met, a Form 4 Sundry Notice will be submitted to COGCC documenting the completion of Interim Reclamation.
