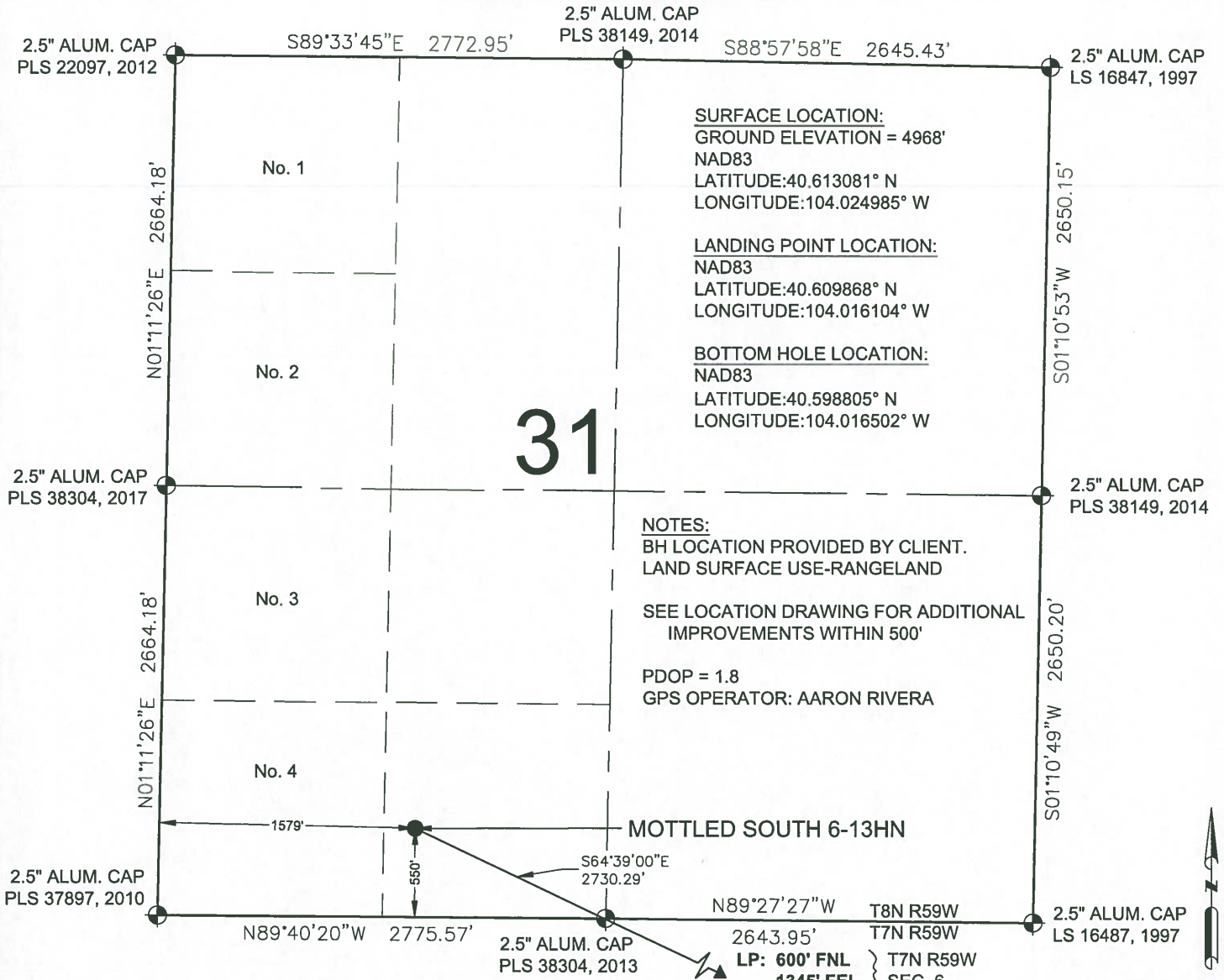


MOTTLED SOUTH 6-13HN WELL LOCATION EXHIBIT

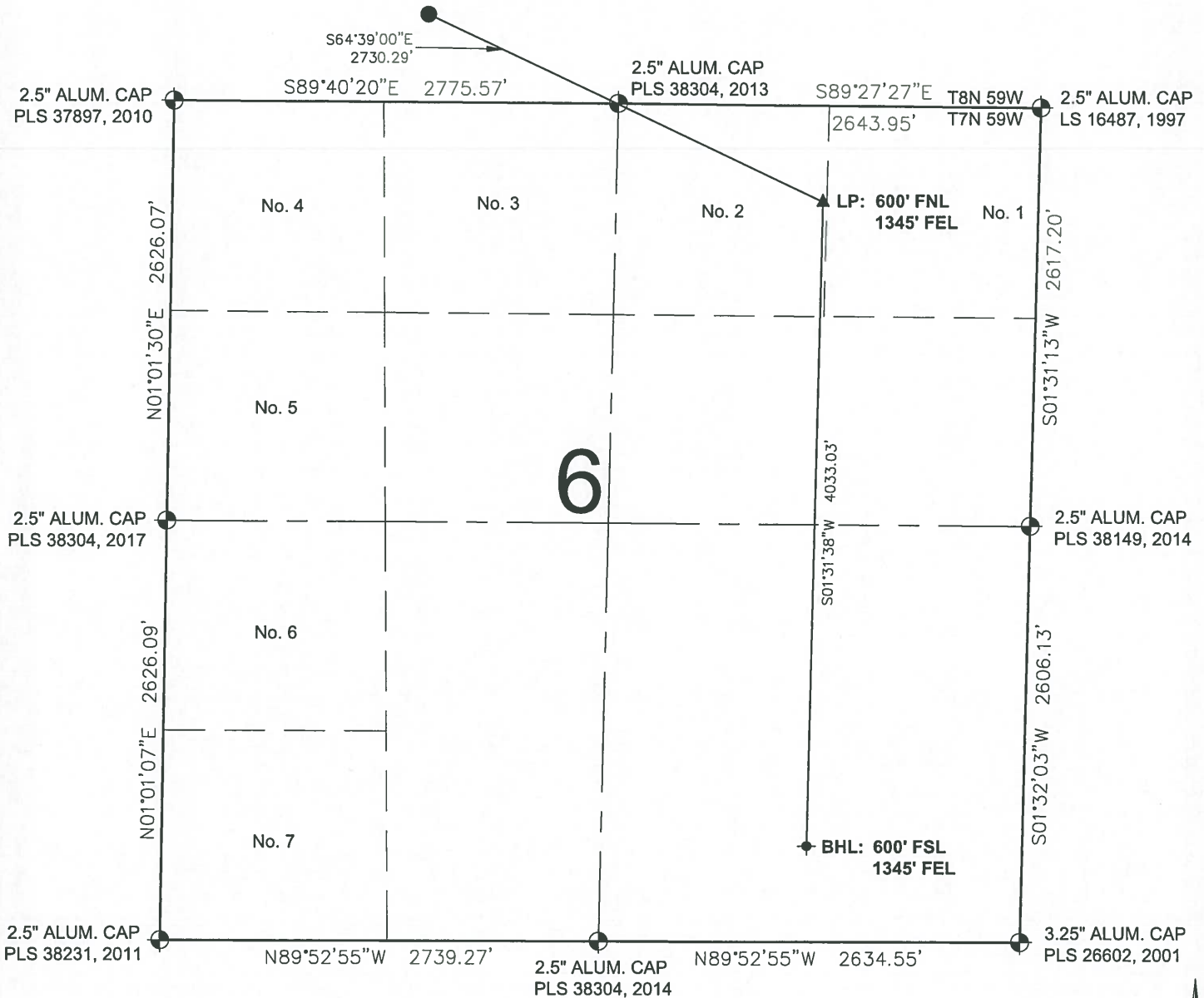
