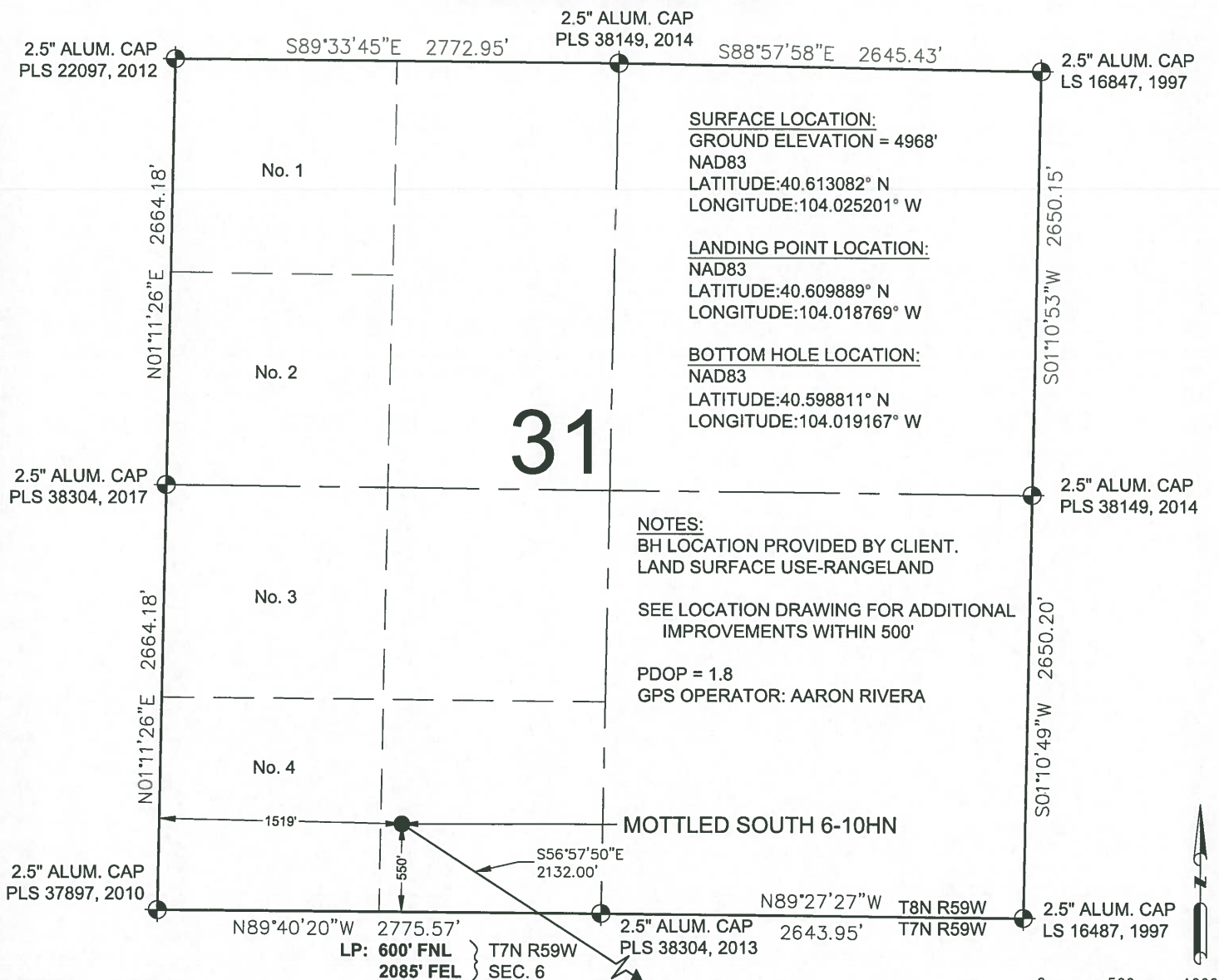


MOTTLED SOUTH 6-10HN WELL LOCATION EXHIBIT

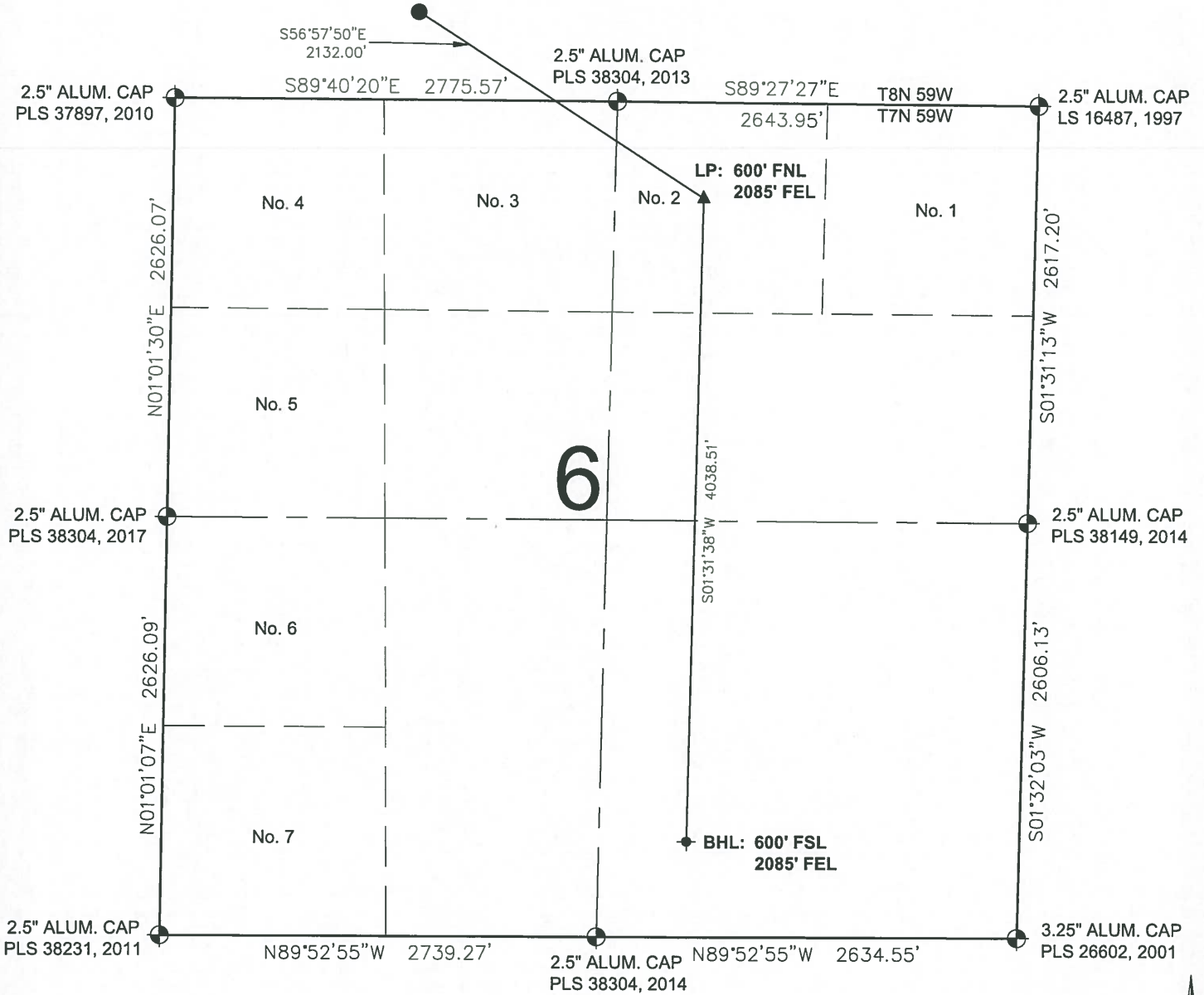
