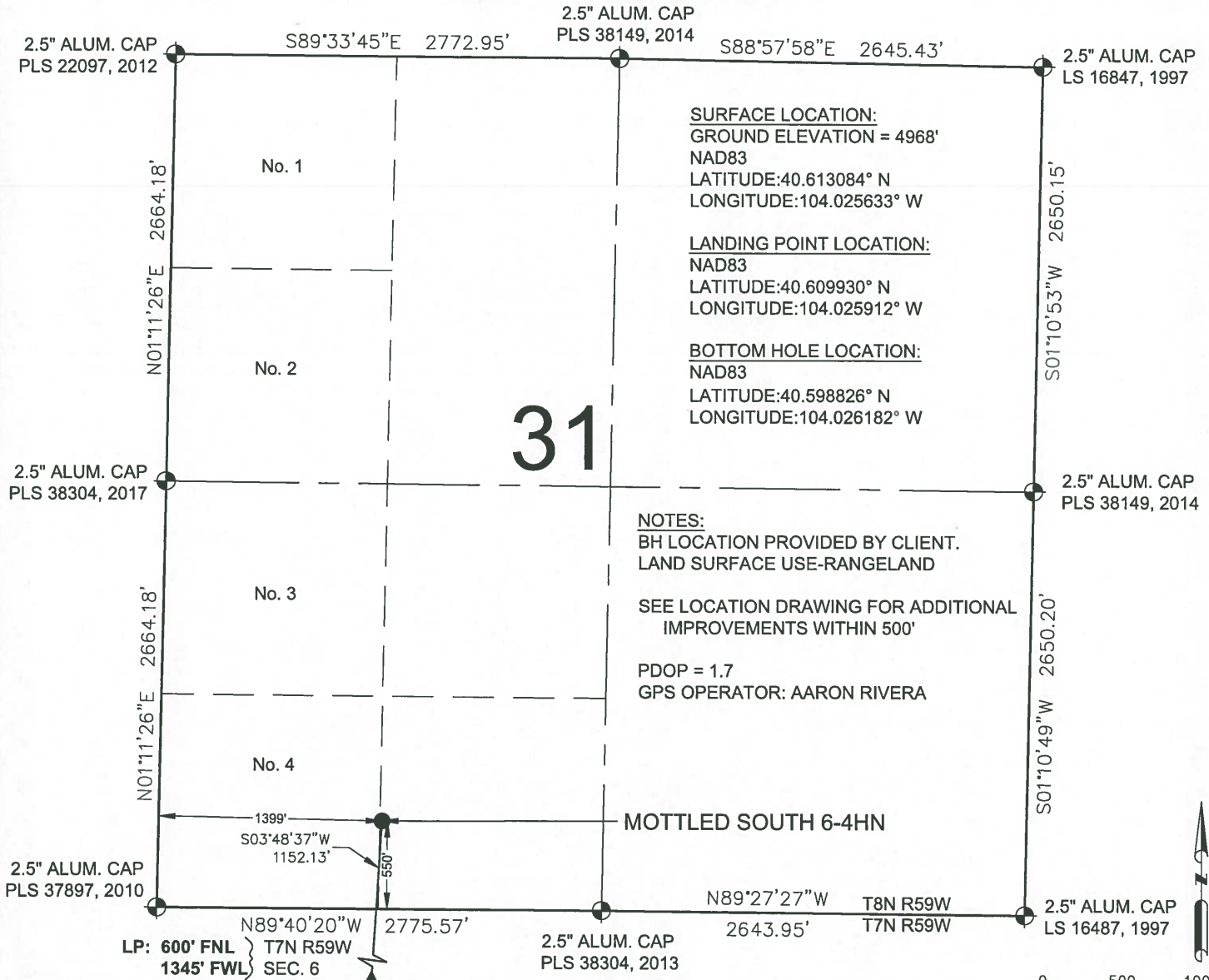


# MOTTLED SOUTH 6-4HN WELL LOCATION EXHIBIT

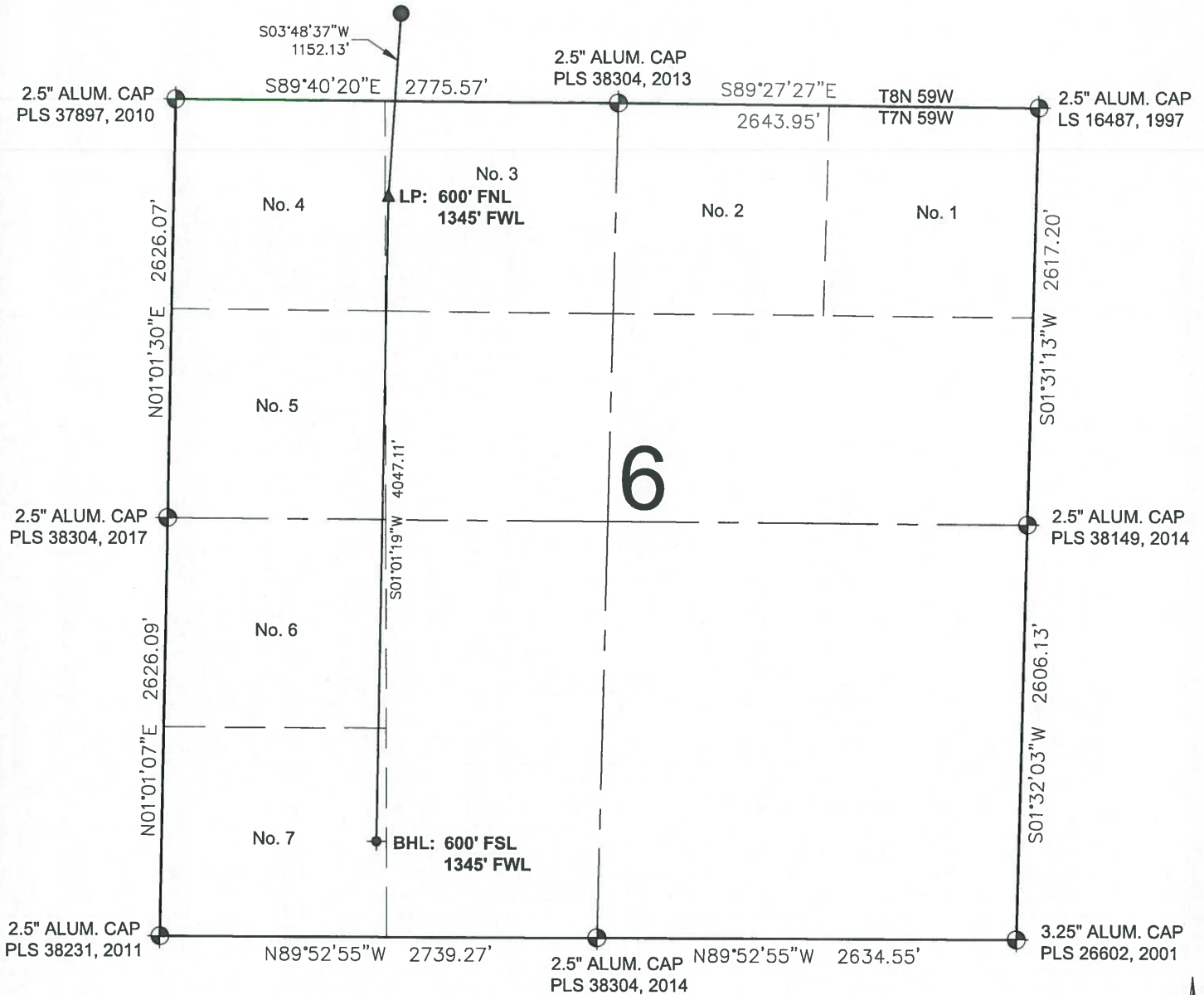
