Comment: Although early in the growing season, revegetation within the working area is poor and does not appear to be progressing. This may be a result of soil compaction. Revegetation needs to be monitored throughout 2018 growing season. If vegetative cover of desirable perennial species to 80 percent of reference area is not achieved, then re-seeding in the fall 2018 planting window (no later than November 1) is required. Decompaction and cattle exclusion may be needed.
