	Inspection Doc. #673715387 dated 5/4/2017 documents location was "just seeded". Reclamation of the location appears to be in process as germination and desirable perennial vegetative establishment is evident. However, no reclamation activities appear to have been conducted on ~0.33 miles of access road leading to the location. In addition, erosion degradation evident on access road. Well was PAd 10/19/2016, all reclamation activities should have completed within twelve (12) months on non-crop land after plugging a well in accordance to Rule 1004.a; reclamation activities should have been completed by 10/19/2017. See attached photo document.	
Corrective Action:	Perform reclamation on access road in accordance to COGCC 1000 series rules including, but not limited to, compaction alleviation, re-contouring, re-grading and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure stormwater and sediment/erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
