On 4-23-2018, I was contacted by COGCC staff in reference to some complaint received by the COGCC in reference to noise. The complaint stated the issues were occurring in the Keensburg area.

On 4-23-2018 I made contact with the complaint who indicated she was experiencing noise coming from what she believed was the Verdad Warner location. I performed a complete site inspection of the location. I reviewed location records, which did not show any abnormal fracking conditions at the time of the complaints. Due to high winds in the area we were unable to run sound study at time of the inspection.

No violation of COGCC rules were observed at the time of the inspection of the frack operation nor in the surrounding neighborhood.
