Comment: Operator has installed a silt fence BMP around the entire perimeter of the location. Operator still plans to install a sediment trap and make repairs to the ditch and berm BMP upon favorable conditions.

BMPs shall be selected based on site-specific conditions, such as slope, soil type, vegetation cover, and proximity to water bodies, and may include maintaining in-place some or all of the construction BMPs until the Location is abandoned and final reclamation is achieved pursuant to Rule 1004. BMPs shall be installed in accordance with good engineering practices.
