Verdad Resources LLC ("Verdad") respectfully asks the COGCC to lift the mitigation COA of the UPRR Ancell 11-1 (05-123-08561) included in the Helen 24-3H (05-123-46822) and the Helen 24-4H (05-123-46830) APDs. Each wellbore was stopped short and the resulting 1,500' buffer excludes the UPRR Ancell 11-1. The Helen 24-3H is 1537 ft away and the Helen 24-4H is 1516 ft away from the UPRR Ancell 11-1.
