Comment:	upon arrival on location staff observed standing water on the west side of the pad. Staff observed an active leak on the injection well located on locaton. Due to the insulation wrap on the well head, staff could not determine to source of the leak. Cogcc Staff called the operator emergency contact number 970-285-2600 at 1607hrs. Operator staff arrived on location at 1730hrs and shut the injection pump down, and determined that the elbow on the injection well 05-077-08854 had washed out, and was the source of the leak. Cogcc staff determined that approximately 5bbl was released onto the pad surface.			
Corrective Action:	Contact the North West Enviromental group to repoet the spill, and complete all required paperwork by 5/31/18. Notify North West Field Inspection Supervisor of all notifications, and forms submitted by 6/22/18.			Date: 06/22/2018
